SUPPLY OF FLUE GAS DESULFURIZATION (FGD) GRADE LIMESTONE FOR

2 X 625 MW ANUPPUR THERMAL POWER PLANT, MADHYA PRADESH, INDIA

- 1.0 MB Power (Madhya Pradesh) Ltd. (MBPMPL), a subsidiary of Hindustan Powerprojects Pvt. Ltd. owns and operate 2 x 625 MW Anuppur Thermal Power Plant (Phase-I) at Jaithari, Dist. Anuppur, in the state of Madhya Pradesh. The project site is located at a distance of about 2 Kms. from Jaithari Railway station on Katni Bilaspur Broad Gauge (BG) section of South East Central Railway (Main Line). Anuppur is the nearest town situated at 15 km. The nearest airports are Jabalpur and Raipur.
- 2.0 MBPMPL has installed Flue Gas Desulfurization System at its 2 x 625 MW Anuppur Thermal Power Plant. FGD System for Unit #1 is operational and FGD System for Unit #2 is expected to be operational in May-24.
- 3.0 To cater the requirement of limestone for FGDs of both the Units, MBPMPL invites expression of interest from competent parties for supply of Limestone at Anuppur Thermal Power Plant on FOR Basis as per details mentioned below:
 - i. Size- 10- 250 mm
 - ii. CaO- Not less than 48.5%.
 - iii. MgO- shall not exceed 2.5%.
 - iv. Sio2- shall not exceed 4.5%
 - v. Requirement- Approx. 7000 MT per month
- 4.0 Party showing intertest in supplying the Limestone matching above mentioned criteria should go through the following qualifying criteria and submit relevant documents on the email ids mentioned below on or before 31-May-24:
 - i. The Party should have its own limestone mine and or a crushing unit.
 - ii. The Party should have sufficient experience in supplying limestone for Thermal Power Plant.
 - iii. The Party shall have an annual turnover of not less Rs. 1 Cr. during any of the last three (3) financial years with positive net worth. Further, the party shall have valid tax documents such as GST, PAN etc.
- 5.0 Interested Parties are requested to submit documents (Lease document of mine, Copies of Orders of similar works and balance sheet of last 3 financial years) evidencing meeting above mentioned qualification criteria to the following mail ids on or before 31-May-2024:
